This Loan and Grant Agreement is made and entered into

BETWEEN:

FEDERATION OF CANADIAN MUNICIPALITIES, a not-for-profit corporation incorporated under the laws of Canada, acting as trustee of the Green Municipal Fund ("GMF"), and

having a place of business at 24 Clarence Street, Ottawa, ON, K1N 5P3.

("FCM")

and

CORPORATION OF THE COUNTY OF DUFFERIN, a municipal corporation established and existing under the laws of the Province of Ontario and having a place of business at 30 Centre Street, Orangeville, ON, L9W 2X1.

("Borrower")

FCM and the Borrower shall be referred to individually as a "Party" and collectively as the "Parties".

This Agreement, including all the schedules described below, constitutes the entire understanding and agreement between the Parties ("Agreement") and supersedes all prior correspondence, offers, negotiations, agreements, or other communications between the Parties, whether oral, written or electronic. No changes or modifications to this Agreement will be binding upon a Party unless in writing and signed by both Parties.

This Agreement will be effective commencing on the date of last signature below (the "Effective Date") and will end on the last day of the Term, unless earlier terminated in accordance with the provisions of the Agreement.
