

Emergency Sign Fees and Options:

Payment must accompany your order.

Sign, \$20.00 plus tax for a total of \$22.60

Sign Post, \$15.00 plus tax for a total of \$16.95 (post is galvanized steel, pre-drilled to accept sign, 7 ft. long, hardware included)

Postage (sign only) \$10.00 plus tax for a total of \$11.30

How do I read the number?

This should be read in conjunction with the **Dufferin County Rural Addressing System Map** (available at our office, free of charge, or by download at www.dufferincounty.ca)

Example: 436265

ROAD NUMBER (first 2 numbers)

All highways, county and township roads have been assigned a two-digit number on the emergency numbering grid. Thus the road in this case is **'43'** which translates to 4th Line, Melancthon Township.

SECTION NUMBER (3rd number)

The third digit indicates the section of the road, as each road is divided into sections numbered 1 through 9. In this example, it is **'6'** which places it north of Highway 89.

KILOMETRIC DISTANCE (last 3 numbers)

The last three digits indicate the distance from the beginning of the section to the driveway. In this example **2.65** km., places this entrance near 5th SDRD.

Civic Addresses

Properties and entrances do not automatically have civic addresses nor does the County of Dufferin stock pre-manufactured signs. Civic addresses are assigned through the County's GIS function as requested.

The signs are made individually at our Operations Center from approved high-visibility and highly durable materials.

Obligations and Responsibility

The Corporation of the County of Dufferin By-law Number 2006-20 is a by-law to provide for the Emergency Numbering of Buildings and Property.

Within this by-law is provision for all property owners, whether rural or urban, to display an assigned emergency number at the access point to their properties. Property includes but is not limited to, a residence, farmstead, development on a private road, vacant land, undeveloped lot, wood lot or land under cultivation.

All costs related to displaying the emergency number in accordance with this section shall be paid by the owner of the land.

Further details include construction, location, maintenance, and enforcement of signs. By-law Number 2006-20 can be downloaded on our website or requested from our office.

If you live in Dufferin County, your emergency sign or "rural civic address" will consist of a 6-digit number. This number uses a grid system to pinpoint the location of entrances.

This number is used by emergency services to locate your property quickly and easily.

If the entrance is to a residence, this number becomes your mailing address.

It is also used for school bus pick-up, utilities services, deliveries, burn permits etc.

The number does NOT legitimize the existence of an entrance to a property.

Contact your local municipality for information on entrance approvals.

How to Obtain your Sign

The County of Dufferin assigns rural civic address numbers on behalf of all the municipalities in Dufferin County.

In order to obtain your civic address, you will need to complete an application.

Through your application you will be assisting our GIS Technician with accurately locating your entrance.

The following information will be required to complete an application:

- ◆ The legal description of the property including lot and concession number
- ◆ A site plan of the newly approved entrance or survey, or a map showing the existing entrance
- ◆ A measurement in feet or metres of the location of the entrance relative to existing entrances and/or from property lines.
- ◆ The tax roll number (found on your municipal tax bill)

Application forms are available from the Public Works office in Orangeville in person, by facsimile, or on-line at www.dufferincounty.ca.

Posting your Sign

The Corporation of the County of Dufferin By-law Number 2006-20 includes details on posting your sign.

Please follow these guidelines:

- ◆ The sign is intended as a driveway marker and therefore should be close to the entrance it is assigned to
- ◆ Place the sign on the SAME SIDE of the road as the entrance
- ◆ Place back from the shoulder of the road, away from damage by snow, grit or road maintenance
- ◆ The sign must be visible to traffic traveling in both directions
- ◆ DO NOT post the sign on a hydro pole. This practice is strictly prohibited
- ◆ Sign should be at least 4 feet (1.2m) above the ground
- ◆ It is highly recommended that signs NOT be posted on mailboxes
- ◆ The sign has 2 holes drilled in one end, covered by vinyl during manufacture. Fasteners are provided. A pre-drilled sign post can be purchased from the County.
