2. ACCESSIBILITY ADVISORY – December 2, 2013– ITEM #2

Making Your Business Barrier-free Breakfast Event.

The Committee reviewed the result of the evaluations from the Making Your Business Barrier Free - Breakfast Workshop. Members in attendance commented it was a great event, and hoped that at the next event attendance would be greater. Staff was directed to send out an email thank you note to all the attendees summarizing the information presented and include links to resources available on the Ministry website.
