

PET REGISTRATION FORM

Pet Owner Responsibilities

Tenants of the County of Dufferin Housing Services who wish to own a pet shall:

1. Notify their Community Services Worker (CSW), Housing Services, of any pet(s) who will be living in their unit, and complete the required "Pet Registration Form" for each pet.
2. Follow all applicable Municipal By-Laws regarding animal ownership and control.
3. Not keep pets for any commercial purpose.
4. Ensure their pet(s) do not cause any noise, disturbance or odour that would interfere with the rights of other residents or the County of Dufferin.
5. Keep their pet(s) under control at all times and kept on a leash when not in the tenant's unit. The pet shall not be left unattended, nor permitted to roam free in common areas, including the lounge, laundry room, hallways, garbage room etc. or elsewhere on the property. Other tenants may be allergic or frightened of them.
6. Provide their CSW with the name and contact information of an individual who will accept responsibility for the pet if the tenant is unable to do so. This individual will acknowledge their responsibility by signing the "Pet Registration Form".
7. Clean up after their animal, in accordance with the directions given, relevant to their place of residence:
 - i. Tenants living in apartment buildings are required to place animal excrement in sealed bags and place the bags in the appropriate garbage container in the garbage room on their floor, or down the garbage chute, if available.
 - ii. Tenants shall use "stoop and scoop" practices when outside the building.
 - iii. Tenants shall not use their balconies as litter boxes for any animal.
8. Be advised that they are responsible for any costs incurred by the County for cleaning, pest control/extermination and/or damage to County property as a result of their pet's actions/behaviour.
9. Notify their CSW when the pet no longer lives with them.
10. Complete the chart on reverse. One form will be required for each pet.
11. Do not wash pet blankets/pillows/toys in the building's laundry.
