2019 UPDATE

Executive Summary

Housing Services at the County of Dufferin provide a wide range of services, including:

- Administration of Dufferin County's Centralized Waitlist for community housing
- Delivery of various Rent Supplement Programs offered in Dufferin
- Management of the Homelessness Prevention Program and programming to address poverty
- Delivery of the Homeownership Program and the Ontario Renovates Program
- Management and operation of the County owned community housing properties
- Working with Local Housing Providers (non-profit and co-operative housing programs)

In 2013, the County of Dufferin, in consultation with the community, created the 10-Year Housing and Homelessness Plan to improve access to housing that is suitable and affordable for all residents in Dufferin. The 10-Year Housing and Homelessness Plan underwent a five-year review and the updated plan was adopted at County Council on November 14, 2019. Annual updates to the plan are posted on the County website.

In this 2019 update, the County has the opportunity to share a summary of progress made in 2019, and acknowledge the efforts of those contributing to our successes.

A Message from the Director

An increase in demand for attainable and community housing was seen in 2019. Housing Services understands the growing need for affordable housing and the additional social programming required to assist the most vulnerable in Dufferin County. Housing staff remain committed to serving clients and tenants in the most dignified manner possible.

Dufferin County Community Services continued to work with the Dufferin County Equity Collaborative (DCEC). In 2019, DCEC hosted the largest *Bridges Out of Poverty* training session Dufferin County has had to date, with 94 attendees. The collaborative acknowledge that there is a need to include the voice of those who have lived/living experience of poverty and inequity. Therefore, the collaborative will work towards the creation of a Lived Experience Advisory Network (LEAN) in 2020.

The County continues to work with local agencies and organizations in a myriad of ways to improve and address local housing and homelessness challenges. Thank you to everyone involved, when we work together we achieve more.


2019 ENGAGEMENT

2019 Housing Forum


The theme of the Housing Forum held on November 22, 2019, set to coincide with National Housing Day, was *Housing: Rising to the Challenges.* The day included a variety of activities and presentations and began with a Privilege Walk, which is an experiential activity that highlights how people benefit or are marginalized by systems in our society. Updates were provided including the Housing and Homelessness Plan, Housing Services Act and Regulations, By-Name List and Homelessness, and Housing Programs. Dufferin County premiered the virtual tours of the County-owned rental units. Dorothy Mazeau from Golden Girls Canada presented on homesharing options for seniors.

2019 Community Engagement Survey

Join In Dufferin, the County of Dufferin's online engagement platform, allows the public to participate in various projects that are happening in the community. Housing Services can engage with the public through surveys, polls, questions and more. A *Join In Dufferin* project page was created for National Housing Day in November 2019. The page featured information about National Housing Day, a quick poll and a survey. Participants attending the Housing Forum were also able to complete the survey on iPads at the event. 2020 OPPORTUNITIES

Relieving Pressure on the Centralized Waitlist

In order to relieve some of the strain on the centralized waitlist, two housing allowance programs will be starting in April 2020:

- Ontario Priorities Housing Initiative (OPHI) Housing Allowance Program a financial supplement paid from the Province of Ontario directly to eligible renter households to help them pay their rent. Households that are eligible for the program could receive \$200.00, \$275.00 or \$350.00 per month starting in April 2020. This program will provide housing allowance supports for clients on the Housing Access Dufferin (HAD) waitlist
- *Canada-Ontario Housing Benefit (COHB)* builds on the Canada-Ontario Bilateral Agreement under the National Housing Strategy and will provide funding directly to approximately 16 households that are on the waitlist

Providing Homelessness Services, Preventing Homelessness & Reaching Functional Zero

Dufferin aims to reach Functional Zero for chronic homelessness by November 2020. Functional Zero is three or less chronic homeless households on the BNL for three consecutive months. In order to reach Functional Zero, the County will be introducing the *Chronic Homeless Housing Allowance Program (CHHAP)*, which will be used to stabilize housing for approximately 15 clients starting in April 2020, and will also be redesigning Coordinated Access so that there are two housing support workers and one housing placement worker.

Non-Profit & Cooperative Housing Providers

Allocation of funding to Non-Profits/Co-operatives/Providers – a total of \$356,567.30 of OPHI funding, under the Ontario Renovates component has been allocated for capital projects. This funding will be largely utilized for roof replacements and the creation of a secondary suite.
