## DEVELOPMENT CHARGES INFORMATION

The Council of the Corporation of the County of Dufferin passed Development Charges By-Law #2022-28 on the 14th day of July, 2022 under Section 2(1) of the ***Development Charges Act, 1997, S.O., 199, c.27***, as amended, effective August 24th, 2022.

This Act authorizes Municipalities to pass by-laws for the partial recovery of net growth-related capital costs incurred to provide services to new residential and non-residential developments. Development charge (DC) funds may only be used for the purpose for which they are collected. These services include the improvements to the

County roads system. The County currently provides 326 kilometres of roads. Road and bridge costs represent about one third of the residential DC.

Other Services for which DC's are collected include ambulance service, child care and early years programs, public health and waste diversion.

In accordance with By-Law #2022-28, DC's by type of dwelling unit and for each service component are listed in the table below. County of Dufferin By-Law #2022-28 applies to all lands in the geographic area of the County of Dufferin.

Development charge rates are indexed annually for inflation.

All DCs must be paid before building permits are issued. Copies of the Development Charges By-Law #2022-28 are available at the County of Dufferin Offices at 30 Centre Street, Orangeville or on our website [dufferincounty.ca](http://dufferincounty.ca).
